### **Recommended City Council Action:**

1. Authorize the Public Works and Utilities Department to apply for an Adams County Open Space Grant for the construction of site improvement and park enhancements at Municipal Court Park associated with the Replacement Municipal Court project.
2. Authorize the Parks, Recreation, and Libraries Department to apply for an Adams County Open Space Grant for renovation, ADA compliance, and stormwater management improvements associated with the Bishop Square Park project.

### **Summary Statement:**

- The Municipal Court Replacement project, at 3030 Turnpike Drive, is being led by the Department of Public Works and Utilities (PWU). The project has included a robust public engagement process, including four Community Advisory Team (CAT) meetings and two public Open Houses, to solicit broader community feedback. Strong public support emerged for park enhancements beyond the currently allocated budget for site improvements.
- PWU intends to apply for an Adams County Open Space (ACOS) grant for \$1.4 million to help fulfill the community's vision for the park enhancements for the Municipal Court Park. The Westminster Local Match (LM) is expected to be \$600,000 and is available within the existing Replacement Municipal Court project budget. No additional City funds are requested to be allocated for this grant application.
- The Bishop Square Park project, at 8150 Hooker Street, is a planned park renovation led by Parks, Recreation, and Libraries (PRL), focusing on Americans with Disabilities Act (ADA) accessibility, sustainable infrastructure improvements, and general park enhancements to better serve the community.
- PRL intends to apply for an ACOS grant for \$2.3 million to supplement the project budget to ensure the successful implementation of key improvements, including an ADA-accessible playground, pavilion maintenance, pathway and parking enhancements, and modernized recreation facilities. The Westminster LM recommended is 30%, or \$690,000, of the total improvement cost of \$2,990,000. Funds for the LM are available.
- The ACOS grant program is a competitive grant process where parks, recreation, trails, and open space projects compete for limited funds made available through the Adams County Open Space Sales Tax. The Spring 2025 grant application cycle deadline is March 28.
- Due to the grant amount, City Council authorization is required to submit the grant application.

### **Policy Issue(s):**

- Should City Council authorize PWU to apply for an ACOS grant to fund park enhancements and site improvements at Municipal Court Park?
- Should City Council authorize PRL to apply for an ACOS grant to fund improvements to Bishop Square Park?

**Alternative(s):**

- City Council could choose not to pursue a grant for additional park enhancements and site improvements at Municipal Court Park associated with the Replacement Municipal Court project. Staff does not recommend this option because, if the grant application is successful, the grant funding would allow the project to be completed and meet the community's full vision of the park design and site improvements.
- City Council could choose not to pursue a grant for the improvements associated with the Bishop Square Park project. Staff does not recommend this option because the City would need to identify new funding sources for this work, leading to a delay in completing the project.

**Background Information:**

Municipal Court Park

The City has engaged the community through four CAT meetings as part of the Replacement Municipal Court project. The group provided historical information and input on the character of the new Municipal Court, park design, and other site elements. Additionally, two public Open Houses were held, allowing for broader community participation and feedback. Throughout these meetings, strong support emerged for site improvements and park enhancements to Municipal Court Park.

The ACOS grant will allow the City to fulfill community priorities and enhance the park's accessibility, sustainability, and usability. The recommended enhancements for the Municipal Court Park include:

- Drought-tolerant landscaping featuring native plants, shrubs, and trees to enhance aesthetics and sustainability.
- ADA accessible sidewalks and paths, ensuring an inclusive, barrier-free experience for all residents.
- Improved pedestrian and bicycle connectivity, integrating the park into Westminster's active transportation network.
- Poured-in-place playground surfacing, providing a safe and accessible play area.
- Site amenities such as seating and gathering areas to encourage community interaction.
- A public plaza with seating, creating a central, inviting space for courthouse visitors and park users.
- Exterior lighting, designed to enhance safety and visibility while creating a welcoming atmosphere.
- Public Art, incorporating creative elements that celebrate Westminster's culture and identity.

- Irrigation system replacement, improving water efficiency and sustainability to align with the City's environmental goals.

The total cost of the Replacement Municipal Court project, including the park enhancements for the Municipal Court Park, is estimated at \$43.9 million. Staff anticipates requesting \$1.4 million in grant funding through ACOS. The LM required, based on a minimum 30% of the total project cost, would be approximately \$600,000.

The Municipal Court Project is a \$42.7 million investment in Westminster's civic infrastructure, ensuring a modern, functional, and accessible courthouse for the community. While the primary funding covers the building and essential site work, additional enhancements to the Municipal Court Park were identified as priorities through the public engagement process.

### Bishop Square Park





Attachment 2 - Municipal Court Park Site Plan




