### **Summary Statement:**

The Government Finance Officers Association of the United States and Canada (GFOA) awarded the City of Westminster the Certificate of Achievement for Excellence in Financial Reporting Award for its 2021 Annual Comprehensive Financial Report, and Distinguished Budget Presentation Award for its 2023 Budget Document.

These documents are judged by impartial review panels to ensure they meet the high standards of the award programs including for the ACFR, demonstrating a “spirit of full disclosure” that clearly communicates the City’s financial story, and for the Budget document, to serve as a policy document, financial plan, operations guide, and communications device.

The Certificate of Achievement for Excellence in Financial Reporting and Distinguished Budget

Awards are the highest form of recognition in governmental accounting, financial reporting, and budgeting, and their attainment represents significant accomplishments by a government and its management.

This is the 39th consecutive year of receiving the Certificate of Achievement for Excellence in Financial Reporting Award and third consecutive year of receiving the Distinguished Budget Award from the GFOA. Staff is honored to receive these prestigious awards in support of City Council's Strategic Priority of Preparedness and Resilience.

**Background Information:**

***Certificate of Achievement for Excellence in Financial Reporting Award***

The City has been awarded the GFOA Certificate of Achievement for Excellence in Financial Reporting Award for the 2021 ACFR. This marks the 39th consecutive year that the City has received this prestigious award, the highest form of recognition in governmental accounting and financial reporting.

To satisfy the requirements of the Certificate program, the ACFR must be easy to read and understand based on a defined reporting framework that incorporates relevant Generally Accepted Accounting Principles and applicable GFOA program policies. Additionally, the information must be reliable as indicated with an unqualified opinion by the City's independent financial auditor.

ACFR reports qualifying for the Certificate of Achievement provide a clear and complete financial story to be utilized by governing boards, oversight groups, investors, creditors, and the public. Westminster's annual report provides accountability for the financial operations and position of the City.

The City of Westminster's report was evaluated by GFOA's special review committee comprised of government finance officers, independent CPAs, educators, and others with expertise in governmental accounting and financial reporting from across the nation. The award acknowledges that Westminster fulfills the spirit of full disclosure in communicating its financial story.

***Distinguished Budget Presentation Award***

The City was also conferred the GFOA Distinguished Budget Presentation Award for the 2023 Budget document. This marks the third consecutive year of the City receiving this award, the highest form of recognition in governmental budgeting.

The award included special recognition for the City's presentation of Strategic Goals and Strategies in the 2023 Budget Document (only 23 organizations received this award in 2022).

In order to receive the budget award, the budget document must satisfy nationally recognized guidelines for effective budget presentation. These guidelines are designed to assess how well an entity's budget serves as:

- a policy document
- a financial plan
- an operations guide
- a communications device

The Distinguished Budget Document Award reflects City Council and Staff's commitment to the highest principles of governmental budgeting.
